TRANSPORTATION & PUBLIC FACILITIES

LADOTD Transportation Alternatives Program

Bicycle and pedestrian facilities, safe routes for non-drivers, converting abandoned railway corridors to trails, scenic turnouts, overlooks and viewing areas, archaeological activities, storm water mitigation, wildlife management, community improvement activities.

FHWA Build-Tiger Discretionary Grants

Improved access to reliable, safe, and affordable transportation for communities in rural areas, improving infrastructure conditions, promote regional connectivity, facilitate economic growth.

LADOTD Enhanced Mobility of Seniors and Individuals with Disabilities

Meeting the transportation needs of elderly and disabled persons.

LADOTD Rural Public Transportation Program

Provide public transportation in non-urbanized areas.

LADOTD Job Access and Reverse Commute Program

Help low-income individuals access to employment and related activities where transit is unavailable.

FHWA Federal Lands Access Program

Improve safety for pedestrians, bicyclists, and transit users.



COASTAL

Coastal Resilience Fund

Restore & strengthen natural systems to protect coastal communities.

Gulf Coast Conservation Grants Program

Strengthening coastal resilience, conservation and management, wildlife and water quality.

Gulf Coast Environmental Benefit Fund

Restoring degraded or altered marine, estuarine, coastal, and freshwater migratory fish habitats.

Coastal Resilience Grants

Conserve and restore sustainable ecosystem processes.

RESTORE Act Direct Component Funds

Protect natural resources, mitigate damage to wildlife, and implement conservation management plans.



RECREATIONAL FACILITIES

FHWA Recreational Trails Program for Louisiana

Recreational trails for a variety of uses.

Land and Conservation Fund

Outdoor recreation, ranging from land acquisition to development of park facilities.



WATER & WASTEWATER

USDA Emergency Watershed Protection Program

Lands that have been damaged by flooding at least once within the previous calendar year or twice within the previous 10 years.

Louisiana DOA, OCD Sustainable Water Management Consolidation Planning Grant (CDBG)

Consolidation of municipal water systems.

Louisiana DOA, OCD Public Facilities Grant (CDBG)

Wastewater systems, including collection lines, treatment, potable water, new construction of graveled residential streets, rehabilitation.

Louisiana DOA, OCD Community Water Enrichment Fund

Rehabilitation, improvement, and construction for community water systems.



Louisiana DOA, OCD Economic Development (CDBG)

Infrastructure improvements which will facilitate the location of a business.

Louisiana DOA, OCD Demonstrated Needs

Improvements to existing sewer & water systems involving collection, treatment, potable water, and improvements to gas systems.

USDA Rural Development

Improve water and wastewater treatment facilities.

Building Resilient Infrastructure and Communities

Hazard mitigation projects to reduce risk from disasters.



FLOOD CONTROL

Delta Regional Authority SEDAP

Community-based and regional projects, address the DRA's mandated four funding priorities.

FEMA Grant Program

Implementing sustained flood reduction program, focusing on reducing or eliminating NFIP claims.

LADOTD Flood Control Program

Channel enlargements, levees, pump stations, relocation of structures.

Louisiana Watershed Initiative

Floodplain mitigation, restoration and preservation, flood storage, critical infrastructure, stormwater management.

USDA NRCS Watershed and Flood Prevention Program

Flood prevention, watershed protection, public recreation, fish & wildlife, agricultural water management, water supply.

Flood control, basic public infrastructure development, transportation improvements.

Public Works Program & Economic Adjustment

Revitalize, expand, & upgrade infrastructure to attract new industry.

Phase 2 Environmental Site Assessments, site cleanup and plan for revitalization.
